## Henniker's Boston Post Cane



In what started out as a gimmick to attract readership, the Boston Post newspaper initiated one of New England's favorite traditions. In 1909 the Boston Post, established in 1836, sent out a specially manufactured cane to 700 towns in New England, including Henniker. They requested that the Town Selectmen present the cane to the Oldest Citizen of the Town. Upon the death of the recipient the cane was to be passed to the next Oldest Citizen, remaining always in the possession of whoever was the Oldest Citizen.

In the early years the Citizen's name was printed in the Boston Post along with a picture of the recipient and the selectmen. The Boston Post ceased business in 1956, but the tradition of awarding a Boston Post Cane has continued in Henniker and in at least 500 other towns. Henniker Selectman determined that in addition to being the Oldest Citizen, the recipient must have resided in Henniker for at least 5 years, must remain in residence for more than 6 months in any one calendar year but did not need to own property. While the original Boston Post Cane was designated for men, in 1947 woman were eligible.

Henniker's original cane is kept in the town vault. Today a replica is awarded and one that the recipient is allowed to keep. The Henniker Historical Society is charged with identifying the oldest citizen and presenting the nomination to the Board of Selectman. As of 2020, 29 Henniker citizens have held the Boston Post Cane, including 15 men and 14 women. The longest the cane has been held by one citizen is Ethel M. Searles who was the Oldest Citizen in Henniker for nearly 13 years when she died at the age of 103.

The present holder, Lois Lorraine Nutting Fitch was born on May 21, 1918 in Gilford, New Hampshire. Lois married Clarence Fitch in 1940 and they lived at the top of Depot Hill in Henniker. They relocated to the "Fitch House" on Bridge Street in 1945 and in 1970 to Hall Avenue. Clarence was the 23<sup>rd</sup> Henniker recipient of the Boston Post Cane in December 2007. Lois currently lives with her son on Rush Road. Lois was presented with the cane on May 21, 2019, her birthday, at the age of 101!
